Certificate of Origin and Value for Mauritius

Instructions

1. Enter the general description of the cargo or merchandise.
2. Specify the name and address of the shipper.
3. Specify the name and address of the recipient (consignee) of the goods.
4. Indicate the mode and name of the carrier.
5. Enter the reference number assigned to this transaction by either the shipper or consignee.
6. Specify the country of origin of each item listed in Block 8 below. This will be the country of manufacture or production of the goods.
7. Specify any marks or numbers on the packages or shipping boxes and crates.
8. Enter the quantity, unit of measurement , and description of the goods being shipped.
9. Leave blank.
10. Enter the amount of value as shown on the commercial invoice.
11. Specify the currency. (Ex. USD)
12. Enter any ocean freight and marine insurance charges if shipped via ocean mode.

Reverse side of form:

13. Complete the statement of value by entering the personal name, business name, address, and country of the shipper.
14. Enter the particulars of any special shipping arrangements unique to the transaction.
- 15(a). Specify the country of manufacture for articles listed in Block 8 which are wholly produced in that country.
- 15(b). Specify any country of partial production or processing for the goods listed in Block 8 if applicable.
16. Calculate the labor costs for the articles being shipped in accordance with the origin certification.
17. Indicate if any special costs such as royalties, packaging, and commissions are included in the cost of the goods.
18. Sign, date, and include witness signature.
